This technical data is collected for internal analysis to help us:

- Measure website traffic
- Monitor site usage trends
- Improve website navigation and content relevance
- Detect and prevent misuse or unusual activity from a single IP address

Use of Personal Information

QuantyPhi does not collect, store, or use personally identifiable information unless you voluntarily submit it. You may choose to provide personal information such as your name, email address, or mailing address when:

- Sending feedback or inquiries
- Requesting information or assistance
- · Submitting forms through the website

By submitting personal information through our website or by email, you consent to QuantyPhi using the information as described in this policy. This information will:

- Be used only to fulfill your request or respond to your inquiry
- Be accessible only to employees performing official duties
- Not be sold, shared, or disclosed to third parties

Limited Exceptions

In certain limited circumstances, such as compliance with court orders or legal obligations, we may be required to disclose information submitted through the website.
